1. In the present petition(s), the grievance of the petitioner(s) is that though, the elections to the various Municipal Councils/Corporations in the State of Punjab are being held on 26.05.2026 but, the elections to the Municipal Council Qadian as well as Municipal Council Dinanagar have not been scheduled to be held on 26.05.2026 and therefore, a direction be issued to the respondents to hold the elections to the Municipal Council Qadian as well as Municipal Council Dinanagar along with the elections of other Municipal Council/Corporations.

2. Learned Advocate General Punjab submits that due to certain

miscommunication, the elections could not be notified qua the Municipal Council, Qadian as well as Municipal Council Dinanagar but, the elections to the said Municipal Council will be held in the 1st week of June, 2026 positively and schedule for said elections will be issued within a period of seven days from today.

3. Learned counsel for the petitioner(s) submits that the reservation of wards qua the Municipal Council Qadian as well as Municipal Council Dinanagar was done vide notification dated 16.04.2026 issued by the State of Punjab and while issuing notification dated 11.05.2026, the reservation qua Municipal Council Qadian as well as Municipal Council Dinanagar has not been disturbed and has been kept intact, therefore, election should be held keeping in view the reservation of wards as per the notification dated 16.04.2026.

4. Learned Advocate General Punjab on instructions submits that as qua the Municipal Council Qadian as well as Municipal Council Dinanagar, no fresh reservation has been done vide notification dated 11.05.2026 hence, the reservation of wards qua Municipal Council Qadian as well as Municipal Council Dinanagar will be as per notification dated 16.04.2026 for holding the elections to the Municipal Council Qadian as well as Municipal Council Dinanagar, which will be held in the first week of June, 2026.

5. Learned counsel for the petitioner(s) submits that in view of the fair stand taken by learned Advocate General, Punjab, no further grievance of the petitioner(s) survives in the present petition(s) hence, the same may kindly be disposed of having been not pressed any further keeping in view the undertaking given by learned Advocate General, Punjab that the elections to the Municipal Council Qadian as well as Municipal Council Dinanagar will be held in the 1st week of June, 2026 as per the reservation provided under the notification dated 16.04.2026 qua the said Municipal Councils.
