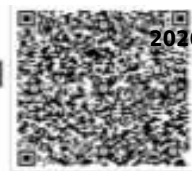

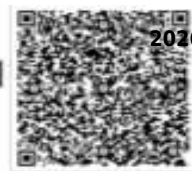
The petitioners have approached this Court for issuance of necessary directions to the official respondents for protecting their lives and liberties which according to them are at stake because they are in a live-in-relationship.

The petitioners claim themselves to be major. However, petitioner No.2/Lakhwinder Singh is not legally eligible to perform marriage being the age of less than 21 years. According to the copies of the identity/age proofs (Annexures P-1 and P-2), the exact date of birth of petitioner No.1 is 01.02.2006 and the date of birth of the petitioner No.2 is 06.11.2005.

The learned counsel for the petitioners submits that a marriage is not a must for providing security to a couple in a 'live-in-relationship' because protection qua life and liberty is sacrosanct and stands at the highest pedestal. He has also placed reliance upon orders passed by the co-ordinate Bench of this Court in '*Sarabjeet Kaur and another versus State of Punjab and others*' in CRWP-102-2022 decided on

07.01.2022 and '*Goutam Kumar and another versus State of Punjab and others*' in CRWP-8088-2021 decided on 26.08.2021 and '*Bharti and Another versus State of U.T., Chandigarh & others, CRWP-9470-2020, decided on 19.11.2020*'.

Notice of motion to respondents No. 1 to 3.

On the asking of the Court, Mr. M.S. Toor, AAG, Punjab accepts notice on behalf of the official respondents. Since no order prejudicial to the interest of the parties is being passed, therefore, there is no necessity of inviting any response.

At this stage, without expressing any opinion on the merits of the case, as well as on the age and nature of the relationship between the petitioners, I deem it appropriate to direct respondent No. 2-Senior Superintendent of Police, Police Distt. Moga, Distt. Moga, to look into the matter and pass an appropriate order in the representations allegedly filed by the petitioners before him on 11.05.2026 (Annexure P-3). It would be appreciated if necessary orders are passed within one month from the date of receipt of copy of this order.

However, if the petitioners are found to have been involved in any other case then this order shall not preclude the competent authority from taking lawful action against the petitioners.
