1. By way of present petitions, the petitioners seek appropriate directions to the Armed Forces Tribunal, Regional Bench, Chandigarh (hereinafter referred to as 'the Tribunal'), to decide the execution applications filed by the petitioners so as to execute the orders passed by the Tribunal extending certain benefits in favour of the petitioners.

2. Learned counsel for the petitioners submits that the respondent authorities did not implement the impugned orders within the stipulated time period of three months, as had been directed by the Tribunal, therefore, the execution applications were filed by the petitioners, seeking a direction for expeditious disposal of the said execution applications.

3. Notice of motion.

4. On the asking of the Court, Mr. S.K. Sharma, Mr. Ashish Chaudhary and Dr. Anju Sharma-Union of India accepts notice on behalf of respondents.

5. Learned counsel for the respondents has not been able to dispute with regard to the aforesaid factual position in all the cases.

6. We have heard learned counsel for the parties and have gone through the record with their able assistance.

7. Considering the nature of relief being sought in the writ petitions and without expressing any opinion on the merits of the cases, the
