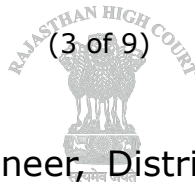

D.B. Review Petition (Writ) No. 215/2026:-

1. The present review petitions have been filed before this Court seeking review of the order dated 20.08.2025 along with applications for condonation of delay in filing the present review petitions.
2. Learned counsel for the respondents have not opposed the applications preferred for condonation of delay in filing the present review petitions.
3. For the reasons mentioned in the application, the same is allowed. The delay in filing the present review petitions is condoned.
4. Heard learned counsel for the parties on the review petitions.
5. Learned counsel for the State, at the very outset, submits that the appropriate remedy with respect to mentioning of wrong pay-scale in the order dated 17.01.2024 passed by the learned Single Judge, is only to file a review petition before the learned Single Judge itself and, therefore, the State may be permitted to file review petition before the learned Single Judge.
6. In these circumstances, learned Additional Advocate General seeks to withdraw the present review petitions as well as the special appeals with liberty to file appropriate petition(s) for review of the order dated 17.01.2024 passed by the learned Single Bench.
7. Although learned counsel for the respondents have not opposed the withdrawal of the review petitions as well as the

special appeals but they have prayed that the respondents may be given liberty to raise all the objections with respect to maintainability of the review petitions before the learned Single Judge.

8. In view of the submissions made before this Court, the present review petitions as well as the special appeals are dismissed as withdrawn with liberty to the State to file appropriate review petition(s) before the learned Single Bench in accordance with law.

9. The respondents will be free to raise all just objections before the learned Single Bench with respect to maintainability and on merit of the review petitions.

10. Needless to say, the time spent in prosecuting the proceedings before the Division Bench of this Court as well as the Hon'ble Supreme Court shall be taken into consideration while considering the applications under Section 5 of the Limitation Act for condonation of delay preferred by the State.
