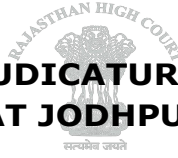

The learned counsel for the parties submit that in pursuance of the mediation proceedings held between the parties the dispute



has been resolved as the mediation was successful. Both the counsel for the parties submit that the present appeals may be decided in terms and conditions as agreed upon between the parties in the mediation proceedings dated 04.05.2026. The terms and conditions agreed upon between the parties before the Mediator are reproduced as under:-

"1. Medication was taken place on 23.04.2026, on that day parties were present alongwith their counsel, one more chance was given to them since their were possibility to settlement and Mediator gave the date on 04.05.2026.

2. Today, i.e. 04.05.2026, in pursuant to earlier date, Both the parties are present alongwith their respective counsels. Both parties are agreed upon that there are no possibility for settlement for living together. However, appellant interested to live together but respondent Rachna has refused. Both parties are agreed upon one issue which pertain to talk with children twice in a month (Vibhor) for that appellant Govind Sahay Berva will call on Rachna Mobile No. 7340579038 by his mobile No.9887671983 between 6:10 pm to 7:00 PM, only by him and not by his parents."

In view of the terms and conditions as agreed upon between the parties in the mediation proceedings dated 04.05.2026 as quoted above, learned counsel for the appellant submits the appellant does not want to prosecute the appeals ad he may be permitted to withdraw the appeals.

In view of the above, both the appeals are dismissed as withdrawn in the terms and conditions as enumerated in the mediation proceedings dated 04.05.2026.
