**Order**

**20/02/2024**

At the outset, learned counsel for the petitioner makes a limited prayer that the petitioner may be permitted to cross-examine the witness(es) upon depositing the cost within a particular time frame.

Issue notice of the writ petition as well as of stay application to the respondents, returnable on 21.03.2024.

The petitioner shall deposit a cost of Rs.5,000/- to the respondents for the proceedings in Civil Original Suit No.29/11 (Sri Maheshwari (Soni) Charitable Trust Vs. Laxmanram & Ors.) and the petitioner is also directed to keep the witness(es) ready along with the affidavit(s) on the next date of hearing for the examination/cross-examination and upon doing so, the trial court is directed to permit the petitioner to examine/cross-examine the witness(es) in Civil Original Suit No.29/11 (Sri Maheshwari (Soni) Charitable Trust Vs. Laxmanram & Ors.).

In case, the cost is not accepted by the respondents and they want to contest the present writ petition, then, they would move an application before the learned trial Court to this effect, in such eventuality, further proceedings in Civil Original Suit No.29/11 (Sri Maheshwari (Soni) Charitable Trust Vs. Laxmanram & Ors.) pending before the learned Civil Judge, Deedwana, District Nagaur, shall remain stayed till next date.

In case, the petitioner fails to utilize the aforesaid opportunity by the next date, then, no further opportunity shall be granted.

List the matter on 21.03.2024.
