1. Instant application has been filed by the petitioner-applicant seeking correction/clarification in the Order dated 16.01.2026 passed in S.B. Civil Writ Petition No. 24234/2025.
2. For the reasons stated in the application, the same is allowed.
3. It is hereby clarified and directed that the Order dated 16.01.2026 shall stand rectified to the limited extent of recording
