1. Mr. Arpit Mehta, learned counsel appearing on behalf of the petitioner- Bank submitted that an application dated 04.10.2025 under section 14 of the Securitisation and Reconstruction of Financial Assets and Enforcement of Security Interest Act, 2002(hereinafter to as 'the SARFAESI Act, 2002') bearing Case No.518/2025 is still pending due to which the petitioner- bank is not able to get possession of the secured assets and recover the due amount.

2. The writ petition is disposed of with the direction to the learned Chief Judicial magistrate, Bikaner to decide petitioner's application dated 04.10.2025 within a period of one month from today, while placing the certified copy of the order instant.

3. It is made clear that the aforesaid direction to decide the application has been issued only with a view to ensure expeditious redressal of petitioner's grievance. The same may not be construed to be an order to decide the application in a particular manner.

4. Stay petition and all pending applications, if any, also stand disposed of.
