1. After hearing the counsel for the petitioner and going through the niceties of the matter, the content of FIR No.137/2025 of Jaswantgarh, Didwana-Kuchaman, the communication exchanged between the parties (Annexure-2) and the complaint moved at the instance of the petitioner (Annexure-3), it is felt appropriate to interfere in the matter. Thus, issue notice to the respondents.
2. Learned Public Prosecutor accepts notice on behalf of the respondents Nos.1 to 9. He is directed to respond.
3. List the matter on 24.02.2026.
4. In the meantime, the petitioner shall appear before the Superintendent of Police, Didwana-Kuchaman and to submit a detailed representation averring therein all those grounds including those which have been raised herein this petition along with documents, if any on which he places reliance, within a period of seven days from now. Upon his appearance and submission of representation, it is expected from the Superintendent of Police, Didwana-Kuchaman to go through it minutely and then pass appropriate directions to the Investigating Officer of this case. Whereafter, a detailed report shall be submitted for the perusal of this Court.
5. Till the next date of hearing, the petitioner shall not be arrested and no coercive measure shall be taken in connection with FIR No. 137/2025 of Jaswantgarh, Didwana-Kuchaman.
