1. Counsel for the appellants submits that the learned Trial Court although proceeded on to partially decree the suit for partition but then did not pass any preliminary decree qua the same. The learned Trial Court also failed to declare the share to which each of the plaintiffs/defendants is entitled.
2. Counsel further submits that the suit was not even maintainable and was liable to be dismissed for non-joinder of the necessary parties.
3. In view of the submission made, Admit. Issue notice. Issue notice of stay application also.
4. Notices be filed in two sets within a period of one week. On the same being filed, one set be given '*dasti*' to learned counsel for the appellants for service through registered post acknowledgment due.

5. Postal receipts of the '*dasti*' notices be filed within a period of one week from the date of receipt of '*dasti*' notices.
6. Notices be made returnable on 08.04.2026.
7. Meanwhile, status quo regarding the property in question shall be maintained.
