Learned counsel for the appellant submits that in the accident in question, the vehicle belonging to deceased's brother has been falsely implicated. It is further contended that, while deciding the claim petition the Tribunal has placed sole reliance

upon the charge-sheet, despite the fact that neither the injury report nor any other supporting document was brought on record as part of the charge-sheet.

The matter requires consideration.

Issue notice to the respondent(s), returnable within six weeks.

Call for record.

In the meantime and till next date, the impugned judgment and award dated 27.11.2025 passed by the learned Judge, Motor Accident Claims Tribunal, Barmer in MAC Case No.414/2022 (Smt. Jheemo Devi & Ors Vs. Thakraram & Ors.) shall remain stayed.
