1. Learned counsel for the petitioners submits that in view of the circular dated 10.05.2016 (Annex.18), the respondents are required to maintain a separate seniority list for TSP and Non-TSP

candidates, however, vide office order dated 22.01.2026 (Annex.8), the respondents have issued a combined final seniority merit list for the post of Assistant Administrative Officer as on 01.04.2025.

2. In view of the submissions made, issue notice to the respondents. Issue notice of the stay application also. Rule is made returnable within four weeks.

3. Additionally, learned counsel for the petitioners is directed to supply a copy of the writ petition to Mr. Sajjan Singh Rathore, AAG, who shall complete his instructions in the matter by the next date.

4. In the meanwhile, the promotions made, if any, in respect of the final seniority merit list dated 22.01.2026 (Annex.8) for the post of Assistant Administrative Officer, the same shall remain subject to the final outcome of the present writ petition.

5. Office is directed to reflect the name of Mr. Sajjan Singh Rathore, AAG, as counsel appearing for the respondents in the cause list.
