1. Learned counsel for the petitioner submits that the petitioner applied for deputation pursuant to the advertisement dated 21.01.2026 (Annexure-8), issued by Respondent No. 1. He submits that as per the guidelines as indicated in the advertisement, the petitioner is required to have three years or more experience in a Swami Vivekanand Government Model School or a Mahatma Gandhi Government School. He further submits that the petitioner worked at Government Senior

Secondary School Gudamalani, Barmer from 16.02.2019 – 11.11.2021, Government Senior Secondary School Mayasar, Nokha, Bikaner from 11.11.2021 – 25.08.2023, Chief Block Education Office in Mahatma Gandhi Government School, Gharsana, District Sri Ganganagar from 31.08.2023 – 06.01.2026, Directorate Secondary Education, Bikaner (APO) from 30.01.2026 till date and has thus acquired more than three years of experience; however, the petitioner's candidature stands rejected while filling the application form, as communicated vide Annexure-10, on the ground that he does not fulfill the requisite experience of three years in a Mahatma Gandhi/English Medium/Swami Vivekanand Model School.

2. Matter requires consideration.
3. Issue notice to the respondents. Issue notice of stay petition as well returnable within a period of four weeks.
4. Meanwhile, the respondents are provisionally directed to accept the petitioner's offline application form, which the petitioner is directed to submit with the respondents on or before 06.03.2026.
