1. Learned counsel for the petitioner submits that the co-accused Mahipal Singh has been granted interim order by a Coordinate Bench of this Court vide order dated 12.02.2026 in S.B. Criminal Misc. Petition No.8494/2025. He submits that the case of the petitioner is at similar footing with the case of the co-accused Mahipal Singh.

2. The interim order dated 12.02.2026 is reproduced hereunder:

“The present criminal misc. petition has been filed by the petitioner under Section 528 BNSS for quashing of FIR No.0135/2023, registered at Police Station Shastri Nagar, District Jodhpur City West for the offences under Sections 419, 420, 465 and 120-B of IPC and Sections 3 and 10 of the Rajasthan Public Examination (Prevention of Unfair Means) Act, 2022.

Learned counsel for the petitioner submits that the allegations levelled against the petitioner is that he remained absent in the examination and in his place one,

Dinesh appeared. Learned counsel for the petitioner has placed on record the documents, as per which, the petitioner as well as Dinesh appeared in different examinations on the same date at different Center. Therefore, the averments on the face of it are false and unsustainable.

In view of the same, this Court is inclined to interfere in the matter. Issue notice. Learned Public Prosecutor accepts notice on behalf of respondent-State.

Let notice be issued to respondent No.2, returnable within four weeks.

In the meanwhile, petitioner shall not be arrested in connection with FIR No.0135/2023, registered at Police Station Shastri Nagar, District Jodhpur City West, however, he shall join the investigation as and when required.”

3. In view of the above, issue notice. Learned PP accepts notice for respondent No.1 – State. Issue notice to respondent No.2 only.
4. In the meanwhile, the petitioner shall not be arrested in connection with FIR No.0135/2023 registered at Police Station Shastri Nagar, District Jodhpur City (West), however, is directed to join the investigation.
5. Connect with S.B. Criminal Misc. Petition No.8494/2025, as prayed.
