HON'BLE MR. JUSTICE KULDEEP MATHUR**Order****25/02/2026**

By way of the present Civil Miscellaneous Application, the petitioner has prayed for recall of the order dated 02.02.2026 passed by this Court in S.B. Civil Writ Petition No. 1156/2026.

Heard learned counsel for the parties. Perused the material available on record.

Upon consideration, this Court prima facie finds that S.B. Civil Writ Petition No. 1156/2026 was not adjudicated on merits. This Court had merely directed the respondents to act in accordance with the orders/notices dated 12.08.2024 and 02.09.2025, stated to have been issued against certain private individuals for removal of encroachments, etc. There is nothing on record to indicate that the said orders/notices dated 12.08.2024 and 02.09.2025 were challenged by the applicants before any competent legal forum.

In view of the above, no case for recall of the order is made out.

However, it is clarified that the present order shall not preclude the applicants from challenging the orders/notices dated 12.08.2024 and 02.09.2025 issued against them by the Nagar Palika, Pindwara, Sirohi, in accordance with law, if so advised.

Consequently, the present Civil Miscellaneous Application stands dismissed.
