In wake of onslaught of COVID-19, abundant caution is being taken while hearing the matter in Court.

Admit. Issue notice. Issue notice of the stay application also. Rule is made returnable within four weeks.

In the meanwhile, the execution of the impugned judgment and award dated 16.01.2020 passed by learned Judge, Motor Accident Claims Tribunal, Bikaner in Motor Accident Claim Case No.43/2011 (1733/2014) shall remain stayed qua the present appellant-Insurance Company provided the appellant-Insurance Company deposits 50% of the total awarded sum after taking into account deposit already made, if any, with the learned Tribunal concerned within a period of one month from today. Upon deposition of the aforesaid amount, the same may be disbursed to the respondents-claimants in terms of the Tribunal's directions, subject to their furnishing an undertaking that in case the appeal filed by the appellant-Insurance Company is allowed, they will refund back the said sum with interest @ 6% per annum.
