Considering the submission that the allegations levelled in the FIR are purely attained with malice and the same can be traced from the FIR itself wherein the allegation for molestation was levelled against the petitioners for the act which was committed on 10.11.2020 and to this effect, the matter was reported to the Police on 20.01.2023 and in the meantime, they contested a long legal battle at different forums. Therefore, I deem it appropriate to interfere in the matter.
2. Issue notice. Learned Public Prosecutor is directed to accept notice on behalf of respondent No.1-State. Learned counsel Mr. Shreyansh Mardia puts-in-appearance on behalf of respondent No.2, thus, service is complete. They are directed to file response to the petition.
3. List these matters after Summer Vacation.
4. In the meanwhile, petitioners shall not be arrested in connection with FIR No.40/2023 lodged at Police Station Abu Road Sadar, District Siorhi and further proceedings pending before the trial Court shall remain stayed.
