1. By way of filing the present writ petition under Article 226 of the Constitution of India, the petitioner has prayed for the following reliefs:-

"It is most humbly prayed that this Hon'ble Court may graciously be pleased to:

(i). Issue an appropriate writ, order or direction, preferably in the nature of Certiorari, thereby quashing and setting aside the Panchayat Election electoral roll 2026 (annex-3) to the extent of the present petitioners wrongly including the name of the petitioners in the voters of ward number -2 Revenue Villages Kalawadanada gram panchayat kalawatsar admittedly petitioners are the permanent resident of the revenue village Balaniya gram panchayat Balau Jati and included the name in the ward number -7 revenue village Balaniya gram panchayat Balau Jati.

(ii) Issue an appropriate writ, order or direction, preferably in the nature of Mandamus, directing the respondent authorities to correct the voter list and restore the voters of Revenue Village Balaniya gram panchayat Balau jati.

(iii) Pass any other appropriate writ, order or direction which this Hon'ble Court may deem just and proper in the facts and circumstances of the present case in favour of the petitioners;

(iv) Award costs of the writ petition in favour of the petitioners."

2. After arguing the matter for some time, learned counsel for the petitioner submitted that the petitioner would be satisfied if the Sub-Divisional Officer, Balotra District-Balotra is directed to consider and decide the representation of the petitioner dated 04.02.2026 for inclusion of his name in the voter-list of revenue Village-Balaniya, Gram Panchayat Balau Jati as the same have wrongly been included in the revenue Village Kalawanada, Gram Panchayat Kalawatsar.

3. This court finds that the prayer made by learned counsel for the petitioner is just and reasonable therefore, the present writ petition is disposed of with a direction to the respondent No. 4 i.e. Sub-Divisional Officer, Balotra to consider and decide the petitioners' representation dated 04.02.2026 seeking inclusion of his name in the Panchayat Election Electoral Roll 2026, revenue Village-Balaniya, Gram Panchayat Balau Jati as expeditiously as possible preferably within a period of two days from the date of this order.

4. It is made clear that the present direction to decide the representation has been issued only with a view to ensure and expeditious redressal of petitioners' grievances and the same may not be construed to be an order to decide the representation in a particular manner.

5. With the aforesaid direction, the instant writ petition as well as the stay application(s), if any, stand disposed of.
