By way of present writ petition under Article 226 of the Constitution of India, the petitioners have made following prayer:-

"It is, therefore, most humbly prayed that this writ petition may kindly be allowed and

- i) By an appropriate, writ, order or direction may kindly be action initiated by the respondent No.1 to alter voter list (Annexure-6) name of the petitioners in the gram panchayat Moti Singh Nagar may kindly be quashed and set aside.
- ii) By an appropriate, writ, order or direction may kindly be issued and the respondent No 1 may kindly be directed to consider petitioners name in the voter list of the gram panchayat deriya as they permanent

resident of the gram panchayat Deriya.

iii) By an appropriate, writ, order or direction may kindly be direct to consider and decide petitioners pending applications.

iv) Any other writ, direction or order necessary for ends of justice be issued.”

Learned counsel for the petitioner submits that the petitioner would be satisfied if the respondent no.3 is directed to consider and decide the representation of the petitioner seeking inclusion of his name in the voter list of Gram Panchayat Deriya. Learned counsel for the petitioner submitted that the name of the petitioner has wrongly been included in the voter list of Gram Panchayat Moti Singh Nagar.

This Court having heard learned counsel for the petitioner finds that the prayer made by learned counsel for the petitioner is just and reasonable. Therefore, the present writ petition is disposed of with a direction to the respondent no.3 to consider and decide the representation dated 01.02.2026 submitted by the petitioner seeking inclusion of his name in the voter list of Gram Panchayat Deriya as expeditiously as possible in accordance with law. It is made clear that the aforesaid direction to decide representation dated 01.02.2026 has been issued only with a view to ensure expeditious redressal of the petitioner's grievances and same may not be construed to be an order to decide representation in a particular manner.

Stay application also stands disposed of.
