1. Petitioners herein, *inter alia*, seek directions to the respondents to grant notional, seniority and other service benefits

on the post of Teacher Grade-III, as granted to similarly situated candidates pursuant to the advertisement of 2004.

2. At the outset, it is submitted by learned counsel for the petitioners that the issue raised in the present writ petition is covered by an order dated 01.04.2015 passed by a Co-ordinate Bench of this Court in ***S.B. Civil Writ Petition No.3247/2015: Hemlata Shrimali & Ors. Vs. State of Rajasthan & Ors.*** He submits that the petitioners are sanguine that, in case they are allowed to file a representation qua the grievance raised in the present writ petition and the same is considered in light of the aforesaid judgment, they will be meted out with favorable treatment.

3. In view of the aforesaid, without commenting on the merits of the case, the petition filed by the petitioners is disposed of with a direction to the competent authority to decide the representation (may file fresh, if not already filed) of the petitioners, in accordance with law, keeping in view the observations made in the judgment, *ibid*, as expeditiously as possible.
