1. Learned counsel for the petitioner submits that the issue involved in the present writ petition is akin to the issue involved in **SB Civil Writ Petition No.3390/2026 : Shree Hari Veterinary College Kotada Vs. State of Rajasthan**, wherein this Court has passed an interim order dated 12.02.2026.
2. In view of the above, matter requires consideration.
3. Learned counsel for the petitioner is directed to supply copy of the writ petition to Mr. S. S. Ladrecha, AAG.
4. Four weeks' time is granted to learned counsel for the respondents to file reply to the writ petition.

5. In the meantime, respondent-Department is directed to permit the petitioner to submit its application under the Guidelines-2025 without insisting upon the condition of deposit of Rs.20 lacs as security amount and the condition of maintaining an average balance of Rs.7 lac during preceding six months.

6. In so far as the issue of application fee is concerned, learned counsel for the respondents submits that a communication has already been issued to petitioner-Institution to obtain refund of the amount already deposited in the year 2022. In these circumstances, respondents are directed to adjust the amount of Rs.5 lac already deposited by petitioner-Institution towards the application fee payable under the Guideline-2025.

7. It is made clear that this order will not create any equity in favour of petitioner-Institution and consideration of petitioner's application will remain subject to the outcome of present writ petition.

8. List the matter after four weeks after showing name of Mr. S. S. Ladrecha, AAG in the cause list.
