HON'BLE DR. JUSTICE NUPUR BHATI**Order****24/02/2026**

1. Learned counsel representing the petitioners, at the outset, makes a limited submission that the respondents may be directed to consider and decide the representation to be filed by the

petitioners by way of passing a speaking order, strictly in accordance with law within a particular time period.

2. In light of such limited submission, it is hereby directed that the petitioners shall submit a detailed representation to the respondents for ventilating their grievances within a period of '10 days' from today. The representation of the petitioner shall be decided by such respondent by way of passing a speaking order strictly in accordance with law within a period of 'four weeks' from the date of receipt of certified copy of this order.

3. With the aforesaid direction, the instant writ petition is disposed of. Stay application as well as all other pending applications, if any, also stand disposed of accordingly.
