1. Counsel for the petitioners submits that in an identical controversy, the Coordinate Bench vide order dated 20.05.2025 passed in **SBCWP No.9934/2025 : "Kanku Bai & Ors. v. State of Rajasthan & Ors."** while issuing notices, had granted interim relief to the petitioners for not disengaging petitioners from the services. The said order is reproduced hereunder:
