1. Learned counsel for the petitioner submitted that in the year 2018, the petitioner purchased a Toyota Fortuner in his own name and duly paid all applicable charges/fees to the respondent Department. Thereafter, in accordance with the prevailing policy of the respondent Department, the petitioner applied for transfer/retention of his earlier registration number, RSB-3333, which had been assigned to his ambassador car, to his newly purchased Toyota Fortuner. Upon consideration of the petitioner's request, the respondent Department lawfully allotted Registration No. RSB-3333 to the new vehicle, i.e., the Toyota Fortuner, and assigned a new registration number, RJ-14-UK-7299, to the Ambassador car. Learned counsel further submitted that, vide notices (Annexure-5) dated 17.12.2025 (published on

18.12.2025) and 26.12.2025, the petitioner was directed to appear before the District Transport Officer, Jaipur-I, along with the vehicle and all relevant documents for inspection and verification.

2. Drawing the attention of this Court to representation dated 24.12.2025 (Annexure-6), learned counsel submitted that, on the said date, in compliance with the directions of the competent authority of the RTO Department, the petitioner duly appeared before the District Transport Officer, Jaipur-I, and submitted all the required documents. However, to petitioner's utter shock and surprise, the Registration No. RSB-3333 issued to in respect of his Toyota Lexus car came to be cancelled on the ground that the same had been issued on the basis of false and fabricated documents.

3. The matter requires consideration.

4. Issue notice. Issue notice of the stay application as well.

5. In the meanwhile, and until the next date of hearing, the effect and operation of the order dated 30.01.2026 (Annexure-7) passed by the District Transport Officer, Jaipur-I, shall remain stayed, and the petitioner shall be permitted to use Registration No. RSB-3333 on his Toyota Fortuner purchased in the year 2018.
