1. An application has been moved by respondent No.1 seeking clarification/modification of the order passed by this Court on 01.12.2025. It is stated that the applicant had filed Special Leave

Petition before the Hon'ble Supreme Court challenging the order dated 01.12.2025. The Hon'ble Supreme Court vide order dated 19.12.2025 has granted permission to the petitioner to withdraw the SLP with liberty to approach the High Court for appropriate relief as may be permissible under law. Therefore, in the present application, learned counsel appearing for the petitioner submits that a clarification may be made in the order passed by this Court on 01.12.2025 and the respondent authority be directed to pass appropriate relieving orders in favour of the applicant and that no order shall be passed for the applicant in further appointment.

2. We notice that the writ petition is pending before the Single Judge for adjudication relating to the order of dismissal. Keeping in view that the order of dismissal is still in force, question of appointment to any other post would not arise. As a consequence of dismissal is that a person cannot be appointed or seek any fresh appointment.

3. In view thereto, no clarification/modification is required. The present misc. application is misconceived and dismissed.
