1. Counsel for the petitioner submits that a similar controversy,
being ***DBSAW No.249/2023 : "Chief Manager, RSRTC v.
Madan Lal Gurjar & Ors."*** is pending before the Division Bench
of this Court at Jaipur Bench, Jaipur; wherein, the Division Bench
has passed interim order staying the proceedings pending before
the Labour Court. He further submits that the Coordinate Bench of
this Court vide order dated 26.11.2025 in *SBCWP
No.22959/2025 : "Ultra Tech Cement Ltd. v. Shimbharam & Anr."*,
has also granted interim relief while issuing notices. The order
dated 26.11.2025 is reproduced hereunder:

*"Learned counsel appearing for the petitioner submits that
similar controversy is pending before the Division Bench of
this Court at Jaipur Bench, which is in regards to the
consequences of the Repealing and Amending Act, 2016*

and the Division Bench has passed an interim order staying the proceedings pending before the Labour Court in Chief Manager, RSRTC v. Madan Lal Gurjar & Ors.: D.B. Special Appeal (Writ) No.249/2023 on 08.05.2023.

In light of the aforesaid interim order passed by the Division Bench, the proceedings pending before the Labour Court is stayed till further orders.

Issue notice to the respondents, returnable in four weeks.

List on 21.01.2026."

2. In this view of the matter, issue notice of the writ petition along with stay application to the respondents.
3. In light of the interim order passed by the Division Bench in the case of **Chief Manager, RSRTC (supra)**, proceedings pending before the Labour Court is stayed till further orders.
