1. Learned counsel for the petitioner submitted that pursuant to the interim order dated 10.02.2026 (Annexure-4) passed by this Court in S.B. Civil Writ Petition No. 3075/2026, titled "Durga Devi Jat vs. State of Rajasthan & Ors.", the petitioner, who had initially been removed from the post of Administrator, was restored to the said post by respondent No. 2 vide order dated 18.02.2026. Pursuant to the order dated 18.02.2026 and the consequential order dated 21.02.2026 passed by respondent No. 2 – Additional

Commissioner and Joint Secretary-II, Rural Development & Panchayati Raj Department, Government of Rajasthan, Jaipur, the petitioner joined as Administrator of Gram Panchayat Narayan Khera, District Bhilwara, on 21.02.2026.

2. Learned counsel further submitted that, without any valid reason or justification, the order dated 18.02.2026 (Annexure-5), whereby the petitioner was restored to the post of Administrator by respondent No. 2, has now been withdrawn.

3. The matter requires consideration.

4. Issue notices. Issue notice of the stay application as well.

5. In the meanwhile and until further orders, the effect and operation of the order dated 21.02.2026 (Annexure-7) issued by respondent No. 2 – Additional Commissioner and Joint Secretary-II, Rural Development & Panchayati Raj Department, Government of Rajasthan, Jaipur, shall remain stayed, and the petitioner shall be permitted to continue working on the post of Administrator.
