1. Counsel for the petitioners submits that the controversy
involved in the present writ petition is similar to the order dated
19.02.2026 passed by this Court in **SBCWP No.3960/2026** :
"Sunita & Ors. v. State of Rajasthan & Ors."; wherein, this

Court had granted interim relief while issuing notices. The order dated 19.02.2026 is reproduced hereunder:

"1. Learned counsel for the petitioners submits that petitioners were promoted from post of Patwari to post of Senior Patwari, however, the respondents have cancelled the promotion without affording any opportunity of hearing vide impugned order dated 03.02.2026 in the second review DPC.

2. Matter requires consideration.

3. Issue notice. Issue notice of the stay application also, returnable within a period four weeks.

4. In the meantime, effect and operation of impugned order dated 03.02.2026 shall remain stayed qua the petitioners.

5. Connect with SBCWP No.3590/2026, as prayed."

2. Thus, in view of the submissions so made by counsel for the petitioners, issue notice of the writ petition along with stay application to the respondents.

3. In the meantime, effect and operation of the impugned order dated 03.02.2026 (Annex.P/7), shall remain stayed qua the petitioners.

4. Connect with SBCWP Nos.3960/2026 & 4704/2026, as prayed.
