The instant application has been filed on behalf of the applicants seeking correction in the cause title of the bail application being **S.B. Criminal Misc. Bail application No.355/2026 (Premaram & Ors. Vs. State of Rajasthan)** filed by them as well as in the cause title of the order dated 23.02.2026 passed by this Court in that bail application.

It is averred in the application that due to typographical and inadvertent error, the name of jail has wrongly been mentioned as 'Sub-Jail Begun' in the cause title of the above mentioned bail application and as a consequence of which, the same error has been occurred in the order dated 23.02.2026 passed in that bail application. However, the correct name of jail is 'Sub-Jail Barmer', therefore, necessary corrections may kindly be made.

Having considered the submissions advanced and on perusal of the bail application being **S.B. Criminal Misc. Bail application No.355/2026 (Premaram & Ors. Vs. State of Rajasthan)** as well as the order dated 23.02.2026 passed by this Court in that bail application, in which corrections are sought; I am of the view that the corrections sought for are essential.

Accordingly, the instant misc. application is allowed.

It is ordered that name of the jail mentioned in the cause title of the above-mentioned bail application as well as in the cause title of the order dated 23.02.2026 passed by this Court in that bail application shall be read as 'Sub-Jail, Barmer' instead of 'Sub-Jail Begun' which is mentioned in the amended cause title filed along with the instant misc. application.

Office is directed to take on record the amended cause title filed along with the instant application.
