1. The petitioner has a long civil nature type dispute with the complainant of this case and different litigations are pending before different forums. There are allegations in the FIR of receiving threat in the name of one renowned gangster for which the petitioners have nothing to do. Looking to the entirety of civil cases pending in between the parties including a suit for specific performance of contract in the Court of Additional District Judge, Pokaran, it is felt appropriate to interfere in the matter.

2. Issue notice.

3. Learned Public Prosecutor accepts notice on behalf of the respondents Nos.1 to 4, thus the notice be issued to the remaining respondents, returnable within a period of three weeks.
