1. Short issue that arises for consideration in present petition is the alleged inaction on the part of respondent authorities in not considering representation of petitioner concerning laying of a 220 KV transmission line.
2. Learned counsel for the petitioner has placed reliance upon Guidelines dated 17.06.2022, issued by Department of Urban Development & Housing, Government of Rajasthan, which provide for safety corridors in respect of high-tension transmission lines. It is submitted that proposed transmission line is passing directly above the residential house of petitioner and, therefore, poses a

potential threat to the safety of petitioner's family as well as other residents of the building.

3. In this background, learned counsel for the petitioner seeks limited indulgence of this Court for issuance of appropriate directions to respondent - District Collector, Udaipur, to consider and examine the representation of petitioner in light of the safety guidelines and other circulars issued by the State Government from time to time, including Guidelines dated 17.06.2022.

4. Learned counsel for the petitioner has also relied upon order dated 17.10.2022, passed by the Division Bench of this Court in ***D.B. Civil PIL Petition 11635/2022***.

5. Having regard to above-stated facts and circumstances of present case, this Court deems it appropriate to grant liberty to petitioner to make a fresh representation before respondent authorities, in light of guidelines/circular issued by State Government, within a period of 7 days from today.

6. In case such representation is filed, District Collector, Udaipur shall consider and decide the same by passing a speaking order within a period of 15 days thereafter, strictly in accordance with law.

7. With these observations, present writ petition is hereby **disposed of**.

8. Stay application and all pending applications, if any, also stand **disposed of**.
