1. Heard learned counsel for the parties.
2. The present habeas corpus petition has been filed by the
petitioner, who claims to be the husband of the corpus Mst. 'K' and
it has been stated in the petition that she is in illegal detention of
respondent No.4.



3. In pursuance of the directions issued by this Court, corpus Mst.'K' has been produced before this Court.

4. We have conferred with the corpus Mst.'K'. She has stated that she is 19 years of age, who understands her well being quite well. She stated that she has studied up to Ist year. She has stated that she wants to go and live with her parents. She is not under any pressure from any side. She stated that she is happily living with her parents and does not want to go with the present petitioner.

5. In view of the statements made before us by the corpus Mst. 'K', we are fully convinced that corpus Mst. 'K' is not in illegal detention of respondent No.4. Since the corpus Mst. 'K' is not in illegal detention of respondent No.4, therefore, the present Habeas Corpus Petition fails and the same is hereby dismissed.

6. The amount deposited by the petitioner in pursuance of the directions issued by this Court on 05.03.2026 stands forfeited.
