In S.B. Criminal Misc(Pet.) No. 2079/2026:-

Counsel for the petitioner submits that the present case arises out of an agreement to sale. The signature on the agreement of entire family is there and only the complainant is backing off and a civil suit is also pending consideration before the Revenue Board and District Court, Jalore

In that view of the matter, this Court is inclined to interfere.

Issue notice.

Learned Public Prosecutor accepts notice on behalf of respondent Nos.1,3 & 4. Notices, thus, is required to be issued to the respondent No.2 only, returnable within three weeks.

In the meantime, the petitioner shall not be arrested in connection with FIR No.21/2026 registered at Police Station, Jalore, District Jalore. However, petitioners shall be required to join investigation.
