Issue notice to the respondent Nos.1 to 4 of the writ petition.

Issue notice of stay petition as well, returnable on 21.09.2020.

Heard on stay petition.

It is noticed that the election proceedings of the District
Football Association, Hanumangarh were challenged by the
petitioners by way of SB CWP No.5228/2020, whereby this Court

vide order dated 03.07.2020 has issued notices to the respondents while observing that staying the election proceedings scheduled to be held on 05.07.2020 is not justified, however, ordered that the result of the election be produced before this Court and the legality of the result of the election shall remain subject to the decision of the above referred writ petition. Pursuant to that the elections were held on 05.07.2020.

Now, the Rajasthan Football Association has recognized newly elected body of the District Football Association, Hanumangarh and allowed it to participate in the election of the Rajasthan Football Association scheduled to be held on 23.08.2020.

Taking into consideration the fact that the election of the Executive Committee of the District Football Association, Hanumangarh held on 05.07.2020 is subjudice before this Court, this Court deems it appropriate to restrain the newly elected Executive Committee of the District Football Association, elected in the election held on 05.07.2020, from participating in the election of Rajasthan Football Association.

Ordered accordingly.
