1. Mr. Rajesh Panwar, AAG appearing on behalf of respondents/contemnors submits that after concluding arguments on 16.07.2026, the Court has granted time till today for compliance of order passed in writ petitions. He submits that the respondent-Authority has initiated action to make compliance of the order and it further requires time as the *patta* has to be issued in compliance of the statutory provisions and statutory provisions require inviting of objection and decision on said objections.
