1. Issue notice to the respondents, returnable within a period of three weeks.
2. Heard on the stay application.
3. Learned counsel for the petitioner submits that the petitioner applied for the post of Assistant Professor (Emergency Medicine)

and he is meeting the criteria of eligibility as per the advertisement dated 27.11.2021 (Annexure-3) including the special training for three years in the respective specialty from a teaching institution. The experience required is only three years whereas the petitioner is having more than three years' experience. His candidature was rejected on the ground that he is not having the requisite experience.

4. On perusal of the advertisement dated 27.11.2021, it can be seen that the requirement is of three years' special training in the respective specialty subject in a teaching institution/centre of excellence. The petitioner is holding such experience as is reflected from the experience certificate dated 03.09.2025 & 15.11.2025 (Annexure-2).

5. In the said circumstances, the respondents are directed to provisionally allow the petitioner to participate in the interview to be held for the post of Assistant Professor (Emergency Medicine) in pursuance of the advertisement dated 27.11.2021 (Annexure-3). However, the result shall not be published without the leave of this Court.

6. List the matter after four weeks.
