The petitioners seek to assail the action of the respondents in not counting their experience for grant of bonus marks acquired after coming into force of the notification Annex.1

dated 08.07.2013 in the recruitment process initiated vide notification Annex.2 dated 11.03.2022. As per the notification dated 08.07.2013, those persons, who had been appointed to the post of Livestock Assistant on fixed pay and were continuously working on that post on the date of coming into force of the aforesaid notification, are entitled for bonus marks having regard to the length of experience exceeding seven years acquired by them. The documents placed on record do not indicate that any of the petitioners had ever been appointed as a Livestock Assistant under the relevant rules or that they acquired experience of more than 7 years by working on such post on a fixed salary basis so as to make them entitled for the benefit under the notification dated 08.07.2013.

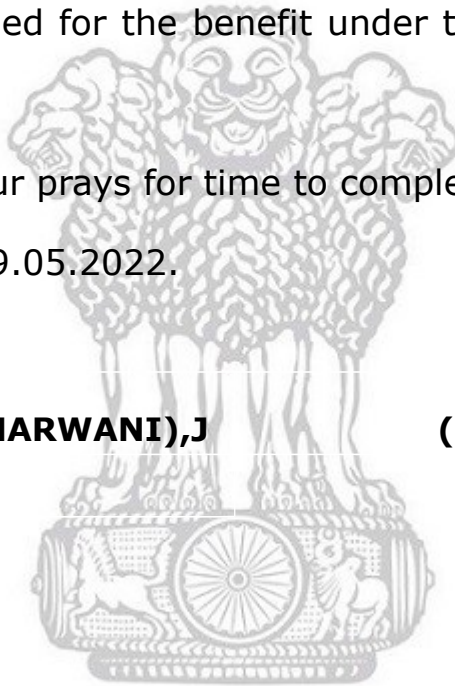
