1. Learned counsel for the petitioner submits that the application filed under Sections 5 and 6 of the ***Rajasthan Religious Buildings and Places Act, 1954, (Act of 1954 for short)*** has been erroneously rejected by the District Collector, Rajsamand.
2. Learned counsel for the petitioner relies upon the term "building" as defined under Section 4(2) of the Act of 1954 and submits that the place in dispute falls within the definition of building and thus, rejection of petitioner's application on the ground of non-applicability of the said Act is apparently erroneous. Learned counsel for the petitioner has also drawn attention of this Court towards interim order dated 24.02.2026 passed in said proceedings.
3. Issue notice. Issue notice of the stay application also, returnable within a period of four weeks.
4. In the meantime, parties are directed to maintain status with regard to land in question.
