1. Learned counsel for the petitioner submits that the controversy involved in the present writ petition is identical to the issue raised in Leela Ram Vs. State of Rajasthan & Ors.: S.B. Civil Writ Petition No.18035/2024, which was decided by a Co-ordinate

Bench of this Court vide order dated 08.11.2024 and therefore same relief be granted to the present petitioner also.

2. The order dated 08.11.2024 passed in SBCWP No.18035/2024, is reproduced hereinbelow:

"1. The present writ petition has been preferred claiming the following reliefs:-

"(a) That by an appropriate writ, order and directions, the respondents may kindly be directed to conduct a survey and measurement of the petitioner's khatedari agricultural land Khasra No.424, 425 & 426 area 24 Bigha is situated in Gramdani village Deva, Tehsil and District Jaisalmer and to do the necessary measurements/ Nekhambandi/ Patthargadi on the boundaries accordingly.

(b) Any other order which the Hon'ble Court considers just and proper in the facts and circumstances of the case may be passed in favour of the petitioner.

(c) The writ petition may be allowed with cost in favour of the petitioner."

2. Learned counsel for the petitioner makes a limited prayer that the respondent authorities be directed to measure and do the Nekhambandi/Patthargadi of the agricultural field of the petitioner situated in Khasra No.424, 425 & 426 area 24 Bigha in Gramdani village Deva, Tehsil and District Jaisalmer, strictly in accordance with law.

3. In view of the above, the present writ petition is disposed of with a direction to the respondents to do the necessary measurement / Nekhambandi / Patthargadi of agricultural field of the petitioner situated in Khasra No.424, 425 & 426 area 24 Bigha in Gramdani village Deva, Tehsil and District Jaisalmer, within a period of 30 days from receiving the certified copy of this order, strictly in accordance with law.

4. All pending applications also stand disposed of."

3. Learned counsel for the petitioner makes a limited prayer that the respondent authorities be directed to measure and do the Nekhambandi/Patthargadi of the agricultural field of the petitioner situated in Khasra No.91/1 and 92/1 ad-measuring 90 Bigha situated in Village Buchawas, Taranagar, District Churu, strictly in accordance with law.

4. In view of the above, the present writ petition is disposed of with a direction to the respondents to do the necessary measurement/Nekhambandi/Patthargadi of agricultural field of the

petitioner situated in Khasra No.91/1 and 92/1 ad-measuring 90 Bigha situated in Village Buchawas, Tehsil Taranagar, District Churu, within a period of 30 days from receiving the certified copy of this order, strictly in accordance with law. Pending application(s), if any, stand(s) disposed of.
