1. Learned counsel for the petitioner submits that vide impugned order dated 24.02.2026 (Annexure-3), recovery has been ordered from the petitioner on the ground of erroneous computation / grant of selection scale.

2. Learned counsel for the petitioner relies upon the interim order passed by this Court in ***S.B. Civil Writ Petition No. 15432/2025 (Dr. Anar Singh Chaudhary Vs. The State of Rajasthan & Ors.)***, dated 14.08.2025, which was passed while relying upon the judgment of the Hon'ble Apex Court in ***State of Punjab & Ors. Vs. Rafiq Masih; AIR 2015 SC 696***.
