is identical to the one in the case titled M/s. J.K. Lakshmi Cement



Limited vs. State of Rajasthan & Ors.; D.B. Civil Writ Petition No. 6501/2020. Said petition has been disposed of vide judgment of even date in the following terms:-

- (a) the petitioner is relegated to the inquiry before respondent No.2, to present his explanation to the impugned show cause notices with supporting material/documents, if any, to enable the former to complete the inquiry and take an appropriate decision;
- (b) respondent No.2 should intimate a fresh date and time to the petitioner for appearance in the inquiry proceedings for hearing including the presenting of his explanation to the show cause notice with supporting material/documents, if any.
- (c) if aggrieved by the decision so taken by respondent No.2, the petitioner may avail the appropriate remedy under law.

2. The instant writ petition is also disposed of in same terms as above. For detailed reasons thereof, reference may be had to the judgment dated 23.02.2026 passed in D.B. Civil Writ Petition No.6501/2020, M/s. J.K. Lakshmi Cement Limited vs. State of Rajasthan & Ors., and the discussion and reasoning recorded therein shall be read as part and parcel herein. Contents thereof are not being repeated for the sake of brevity.

3. Pending application(s) shall stand disposed of.
