1. Learned counsel for the appellant has placed reliance upon a
judgment rendered by the Hon'ble Supreme Court in
R. Logeshkumar versus P. Balasubramaniam & Anr. reported
in ***2026 (1) R.A.R. 121 (SC)*** decided on 05.12.2025.
2. The matter requires consideration.
3. Issue notice to respondent(s), returnable within six weeks.
4. Learned trial court is directed to send the record after
disbursal of the claim amount to the respondent(s).

5. Meanwhile, effect and operation of the impugned judgment and award dated 30.01.2026 passed by the learned Judge, Motor Accident Claims Tribunal, Rajsamand in Motor Accident Claim Case No.201/2024 (CIS No.201/2024), shall remain stayed qua the appellant subject to the condition that the appellant - Insurance Company deposits 50% of the amount (with interest) awarded by the Tribunal vide award dated 30.01.2026 within a period of eight weeks. The amount so deposited shall be disbursed to the claimants by the Tribunal in accordance with law. The amount previously deposited, if any, shall be adjusted.

6. It is made clear that if the amount as directed by this Court is not deposited within the stipulated time, the respondent claimants shall be free to proceed with the execution of the impugned award.

7. In case, the appeal is decided against the claimants, the amount so deposited by the insurance company shall be returned by the claimants to the appellant-insurance company along with interest.
