**HON'BLE MR. JUSTICE KULDEEP MATHUR**

**Order**

**25/03/2026**

1. Mr. Madhav Soni, learned counsel, appearing as associate to  
Mr. Paramveer Champawat, Advocate, submits that he has filed a  
caveat in the matter on behalf of respondent No. 3. However,  
neither is such caveat available on the case file nor is it reflected  
on the official website of the Rajasthan High Court.
2. Learned counsel for the petitioner submits that he has also  
not received any caveat on behalf of respondent No.3. In that  
view of the matter, this Court proceeds to consider the matter.
3. Learned counsel for the petitioner further submitted that, in  
a writ petition involving a similar controversy, being S.B. CWP No.

16028/2025, a Co-ordinate Bench of this Court has been pleased to pass an interim order in favour of the Co-operative Societies on the ground that, prior to conducting inspection of the Milk Producers' Societies, neither any notice was issued nor was the inspection carried out in the presence of the members of the society.

4. In view of the aforesaid, issue notice of the writ petition as well as of the stay application to the respondents.

5. List the matter along with S.B. CWP No. 16028/2025.

6. In the meanwhile, and until the next date of hearing, the effect and operation of the order dated 23.02.2026 passed by the Managing Director, Chittor, Pratapgarh Dugdh Utpadak Sahakari Sangh Ltd., Chittorgarh, shall remain stayed.
