1. Petitioner has preferred the present writ petition against inaction of the respondent- Superintendent of Police, Jodhpur, who has failed to determine the amount payable by the petitioner in furtherance of the order dated 17.02.2026 (Annex.5), passed by the Chief Judicial Magistrate, Jodhpur under Section 14 of the Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act, 2002.
2. Learned counsel for the petitioner submits that in furtherance of the order dated 17.02.2026 (Annex.5), though the petitioner has requested the Superintendent of Police to calculate the payable amount for providing police assistance to the petitioner, yet the same has not been determined.
3. The present writ petition is disposed of with a direction to the petitioner to file a certified copy of the order instant before the

Superintendent of Police, Jodhpur along with requisite particulars/ documents/ details within a period of two weeks.

4. On receipt of the application, the Superintendent of Police shall calculate the amount to be paid by the petitioner for providing Police aid. Whereafter within a period of two weeks from deposition of the amount, the Superintendent of Police shall provide police aid for securing possession of the secured assets as mentioned in order dated 17.02.2026 (Annex.5).

5. Stay application also stands disposed of accordingly.
