S.B. Civil Writ Petition No. 3277/2023:

1. Mr. Khileree, learned counsel for the petitioners submits that in identical writ petition being S.B. Civil Writ Petition No. 1817/2022 (Suraj Kumar Jeengar & Ors. vs. State of Rajasthan & Ors.) a co-ordinate Bench of this Court has granted interim order in those petitioners' favour on 03.02.2022 and petitioners' case is not different.
2. After hearing learned counsel for the parties, this Court finds that the issue involved in the case of Suraj Kumar Jeengar (supra) is identical to the present petitions.
