1. Learned counsel for the petitioner submitted that the
Registration Certificate of the vehicles bearing No.AR20E4455,
AR20C3555, AR20B3555. AR20D4545 and AR20C4545 issued by
the competent authority in the State of Arunachal Pradesh in
favour of the petitioner, could not have been suspended by the
Registration Authority in the State of Rajasthan, i.e., the District
Transport Officer, Jodhpur, vide order dated 30.12.2025.
2. Learned counsel further submitted that the Hon'ble Supreme
Court of India, in SLP (C) No. 3413/2025 titled Mahendra Gupta
vs. State of Madhya Pradesh & Ors., has held that the Registration

Authority of one State cannot suspend a registration certificate issued by another State. However, the competent Transport Authority of the State in which the vehicle is sought to be plied may impose restrictions if the vehicle does not conform to the regulations applicable in that state.

3. The matter requires consideration.
4. Issue notice. Issue notice of the stay application as well.
5. In the meanwhile and till further orders, the effect and operation of the impugned order dated 30.12.2025 passed by the Registration Authority-cum-District Transport Officer, Jodhpur, suspending the registration of the petitioner's vehicles bearing No.AR20E4455, AR20C3555, AR20B3555. AR20D4545 and AR20C4545 shall remain stayed.
6. However, the Registration Authority-cum-District Transport Officer, Jodhpur/any other competent authority of respondent department shall be at liberty to issue appropriate directions restraining the petitioner from plying the said vehicles within the State of Rajasthan.
