1. The instant petition has been filed on behalf of the petitioner seeking fair investigation in the matter and providing appropriate protection to them for raising construction.

2. Heard learned counsel for the parties.

3. The instant writ petition is disposed of with the following directions:-

a) The petitioner shall move a representation to the Superintendent of Police, Udaipur. Patient audience shall be given to him and it is expected that the Superintendent of Police shall sensitize the Circle Officer and SHO, Police Station Ghasa. It shall be ensured that the decree passed by Civil Judge on 14.12.2023 is strictly complied with to the extent that unlawful force of the respondent shall be thwarted.

b) If an application is moved before Civil Judge, Mawli in relation to either execution or compliance of the decree dated 14.12.2023 by the parties to this suit, the same shall be considered appropriately in accordance with law.

c) The SHO, Police Station Ghasa shall ensure that illegal encroachment and unauthorized interference shall not be allowed and no interference shall be made with the constructions, which is subject matter of FIR No.27/2026 registered at Police Station Ghasa, Udaipur if it is in accordance with and in consonance with civil rights which has been already adjudicated by the Civil Judge.
