The prayer made by learned counsel for the petitioners for staying deposit of GST during the process of admission which is being sought to be resorted to by the petitioners cannot be accepted in light of various orders passed by a Division Bench of this Court, one of which being order dated 04.08.2022 in *D.B. Civil Writ Petition No.7559/2022 (Swa Poshit Shikshak Prashikshan Mahavidyalaya Samiti Vs. Mohanlal Sukhadia University, Udaipur and Ors.)*, where following order was passed:-

*"In D.B.Civil Writ Petition No.7559/2022, all the respondents are served through their respective counsel. Reply may be filed/ similar reply in other cases may be adopted, within one week.*

*In D.B.Civil Writ Petition No.2906/2022, pleadings are complete.*

*Instead of considering various interim applications which are pending, on the prayer for grant of interim relief, the petition itself be listed for final hearing in the first week of September, 2022.*

*After hearing learned counsel for the parties, we reiterate our earlier order passed that any payment*



*towards GST shall be subject to the final outcome of the writ petition."*

In light of the above, the prayer made by the learned counsel for the petitioners is not accepted in toto, however, the amount to be deposited as payable under the GST shall be subject to the final outcome of the writ petitions.

Learned counsel for the petitioners is directed to supply a copy of the writ petitions to Mr. Rajvendra Saraswat, learned counsel for the CGST Department during course of the day.
