The instant misc. application has been preferred by the petitioner seeking correction/modification of the order dated 22.04.2026 passed in S.B. Criminal Misc. Petition No.3202/2026.

Learned counsel for the petitioner submits that he had sought an order for fair investigation in the present case and the Hon'ble Court was pleased to allow the same but, however, the same came to be wrongly recorded in the order-sheet dated 22.04.2026.

He submits that the order-sheet reflects that the misc. petition is dismissed as not pressed, however, order of fair investigation was passed.

This Court has considered the misc. application as well as checked the record and finds that limited prayer for fair investigation was accepted by the Court but due to inadvertence and clerical error, wrong order came to be recorded in the order-sheet on 22.04.2026.

In view of the same, the misc. application is allowed.

Accordingly, order dated 22.04.2026 passed by this Court in S.B. Criminal Misc. Petition No.3202/2026 shall now be read as under :-

"The instant misc. petition has been filed by the petitioner-complainant under Section 528 of BNSS with a limited prayer that the Investigating Agency may be directed to conduct fair and impartial investigation in FIR No.158/2026 registered at Police Station Udai Mandir, District Jodhpur City East for the offences under Sections 318(2) and 61(2) of BNS, 2023.

Learned Public Prosecutor submits that the Investigating Agency is already conducting fair and impartial investigation, however, if any material is brought on record by the petitioner, the same shall be considered by the prosecution strictly in accordance with law before completing the investigation.

Taking into account all the facts and circumstances of the case, the petitioner is directed to submit a detailed representation before the Investigating Officer within a period of three weeks from today, who shall take up all the facts as well as contentions raised in the representation and complete the investigation by considering them strictly in accordance with law.

The instant misc. petition is disposed of accordingly.

Stay application and all pending application(s), if any, stand disposed of."
