1. The present contempt petition has been filed alleging disobedience of interim order dated 22.06.2021 passed in S.B. Civil Writ Petition No.7596/2021.
2. It is an admitted fact that during the pendency of the present contempt petition, petitioner Nos.1 and 5 were permitted

to rejoin. So far as petitioner Nos.2 to 4 are concerned, vide order dated 20.01.2026, they were directed to remain present before the authority concerned on 28.01.2026 to join their duties. As per communication dated 09.02.2026 placed on record by counsel for the respondents today, only petitioner No.4 Indu Choudhary moved an application to join. The other two petitioners i.e. petitioner Nos.2 and 3 neither remained present nor they moved any application to join.

3. On put to a query, counsel for the petitioner is not in a position to satisfy the Court firstly, as to whether the petitioners remained present before the concerned authority on the stipulated date and secondly, whether they moved any application to be permitted to join.

4. In view of the above, when the petitioners themselves are not inclined to join and did not comply with order dated 20.01.2026, this Court is not inclined to continue further with the present contempt proceedings and the same is hence, **disposed of.**

5. Rule stands discharged.
